Students must enroll in at least 6 units each quarter and maintain a quarter-to-quarter, as well as a cumulative minimum GPA of 2.0 and passing at least 67% of the registered courses to be eligible for Federal Student Aid.

Your AMU Application for Federal Student Aid (FSA) will be processed after you are officially accepted into the program and before your first loan period starts. Your school email address @amu.edu will be used for all official communications once it's assigned.

The Loan Period is the same as the Award Year, i.e., 7/1 to 6/30, at AMU. For each loan period, you need to submit the AMU FSA Loan Request Form before your new loan period starts. You may request the amount equal to or less than the maximum amount \$20,500 of the Unsubsidized Loan (UNS) for full-time enrollment given that you have not exceeded the aggregate limit \$100,000 (OBBBA, effective on July 1, 2026). and will be evenly disbursed in your eligible quarters. Your request amount will not change during the loan period. However, **your disbursement amount will be recalculated using actual enrollment and adjusted to ensure total disbursements do not exceed the updated Schedule Of Reductions (SOR) annual amount.** Please budget accordingly.

As an FSA student, you don't need to pay tuition/fees until after the disbursement which is normally around the 4th week after the Add/Drop period ends. After deduction of tuition/fees, you'll receive the remaining credit or pay out of pocket for the remaining balance within 3 days of the disbursement notice to avoid late fees.

To be eligible for FSA, you must maintain Satisfactory Academic Progress (SAP, please see AMU Catalog) and enroll at least half-time, i.e., 6 units, for the quarter you want to receive FSA. Whenever your enrollment drops below 6 units, you must complete the Exit Counseling (<https://studentaid.gov/exit-counseling/>), required by law, your 6 month grace period starts, and you may need to return the unused portion of your FSA funds which is calculated based on your Last Date of Attendance (LDA). That is Return To Title IV (R2T4). Please contact the Director of Financial Aid (fsadirector@amu.edu) before your enrollment may drop below 6 units.

For repayments, please contact your Loan Servicer assigned by the Department of Education. Please monitor your statements from your loan servicer which has the most accurate amount of your repayment.

I acknowledge that I have read and understood the statements provided above. I understand that I must submit all required documents and adhere to FSA and AMU requirements and policies in order to receive Federal Student Aid. I understand failure to meet the requirements may impact my eligibility and disbursement of Federal Student Aid.
